Background and current projects

Dissertation research—"Localizing Production: Geographical Indications and their Impact on Rural Development." In my dissertation, I compare three GI production systems (tequila in Mexico, Antigua coffee in Guatemala, and Comté cheese in France), in order to evaluate the effects of GI protection on rural development and outline the factors that contribute to more sustainable and equitable systems of GI protection. I employ a variety of methods, including in-depth interviews, economic case studies, and participant observation. I examine: (1) the distribution of economic, social, cultural, and ecological benefits that are associated with GI protection, (2) the regional power dynamics that are unfolding as a result of GI protection, and (3) the ways in which local, regional, and national actors influence, and are in turn influenced by, the creation of GI policy and standards.

Commitment to participation and confidentiality

I agree that none of these provisions may be interpreted as granting a license and/or any right and/or title whatsoever for the use of this Confidential Information.

I agree that any use of this Confidential Information shall be subject to the prior signature of an agreement with the owner(s) of the Confidential Information (including myself). However, Information shall not be deemed as confidential if an associate researcher is able to prove:
