Databases

Publications (Bibliography)

- Armelle Champenois, Corinne Couillerot and Claire Samson produce a **mask** for registering the publications and communicate the final version to Dominique Barjolle. Dominique Barjolle will do the **Access-Database** (mde-version) and send it to each researcher before end of August.
- The researchers send the completed files to Dominique Barjolle before Florence Meeting. She will merges the files into the final database.
- The responsible of each WP will send an e-mail to each researcher to get relevant references from countries which are not part of the program.
- Corinne Couillerot asks for solving the problem of the installation of the database on the web page.
